



## ***Nu Skin's Autumn Offers Promotion*** **TERMS & CONDITIONS**

1. The Promotion will be valid in South Africa from 9:00 AM SAST/CEST on Thursday 23 April 2020 until 11:59 PM SAST/CEST on Thursday 30 April 2020 and **only for as long as the stock indicated in Exhibit A lasts** during this period.  
**For the avoidance of doubt, this means that if the promotional stock for a specific SKU, as indicated in Exhibit A, has been sold out, the Promotion will end for that SKU. This will be the case even if the end time of the Promotion, as indicated above, has not been reached. This also means that the Promotion will end at 11:59 PM SAST/CEST on Thursday 30 April 2020, even if there is still promotional stock left.**
2. The Promotion will consist of a **20% discount** applied automatically on each of the products listed in Exhibit A (together referred to as the "Promotional Products") purchased via your local Nu Skin website ([www.nuskin.com](http://www.nuskin.com)). Depending on whether you are a Brand Affiliate/Member or Retail Customer, the 20% discount will apply to the Member Price, respectively the Retail Price.
