



CHRISTMAS PROMOTION TERMS AND CONDITIONS

Nu Skin (Malaysia) Sdn. Bhd. (“**Nu Skin**”, “**we**” or “**us**”) will be running the “October Promotion” (“**Promotion**”) starting from 4 December 2023 till 26 December 2023 or upon depletion of the stock made available for this Promotions, whichever comes first (“**Promotion Period**”).

For the purposes of these Terms and Conditions, “**Company**” refers to Nu Skin International Inc. and its affiliates. GENERAL TERMS AND CONDITIONS

By participating in this Promotion, you consent to the Company's collection, use and disclosure of your personal data with us, including your name, email address, and photographs, for the purposes of administering and promoting this Promotion. Such termination or suspension shall not entitle you to any claim or compensation against Nu Skin or our related entities for any and all loss or damage suffered or incurred as a direct or indirect result of the act of termination or suspension.

- (a) to comply strictly with all Promotion timelines, mechanics and the terms and conditions provided herein;
- (b) to indemnify Nu Skin fully and hold Nu Skin harmless for any liability resulting from Participants' breach of the Website Terms of Use and these Promotion terms and conditions;
- (c) to have read, understood and to be bound by the terms and conditions herein, the Policies and Procedures, the Brand Affiliate Agreement and International Sponsor Agreement and the Resident Market Product Purchase Agreement (if applicable); and

The rest of these rules or terms and conditions shall not be affected and shall continue in full force and effect as if the void or unenforceable term and condition, or any part thereof, had never been contained herein.
