



## Oh, Boost! Testimonial Contest (the “Contest”)

Nu Skin Enterprises Philippines, LLC (“**Nu Skin**”, “**us**”, or “**we**”) is holding the Contest. To participate, we want you to share with us about how you have benefitted from using ageLOC Boost.

These terms and conditions adopt the definitions and abbreviations found in the Nu Skin Brand Affiliate Agreement (Philippines), Nu Skin Policies & Procedures (Philippines) and the Nu Skin Sales Performance Plan (also known as “**Velocity**”). Any undefined capitalized terms can be found in the aforementioned documents.

You accept the terms and conditions of this Contest when you participate in this Contest. You may withdraw from this Contest by notifying us in writing at any time.

### Eligibility

1. To be eligible for the Contest, you must be a Brand Affiliate who signed up with Nu Skin Philippines; and
2. Purchased an ageLOC Boost System Kit during the product preview, prelaunch and official launch in the Philippines.

### Contest Mechanics

3. To participate in the Contest, you need to first share with us your thoughts on any of the following questions:
  - a. What makes ageLOC Boost attractive?
  - b. Why do you love ageLOC Boost?
  - c. How did ageLOC Boost improve your image?

Second, we need you to share with us your before-after pictures showing the improvements you experienced from using the ageLOC Boost System. A complete entry comprises your written thoughts together with two (2) before-after pictures.

6. Your Contest entry must have a minimum length of 30 words and cannot exceed 50 words and must comply with Nu Skin's opportunity and product testimonial guidelines.
7. Your entry photographs must be two (2) high-resolution photographs. The first photograph shall be taken on the day you commence using the AgeLOC Boost System, and the second photograph at the end of your 12<sup>th</sup> week of use of the System. All submitted photographs must comply with the following guidelines:

By participating in this Contest, you consent to Nu Skin's collection, use and disclosure of your personal data with us and within the Contest entries, including your name, email address, and photographs, for the purposes of administering and promoting this Contest.   - a. You shall comply strictly with all deadlines and Contest rules issued or given by Nu Skin.



- b. It is your responsibility to access Nu Skin's website at regular intervals to view any changes to the terms and conditions of this Contest and Nu Skin is not obliged to notify you of any changes.
  - c. You shall only submit unedited and original content produced by you, in accordance with the Contest requirements (the "**Content**").
  - d. The Content shall be true to the best of your knowledge and belief.
  - e. Nothing in the Content that you submit to us shall contain anything (save for Nu Skin's products) which would infringe the intellectual property rights of any intellectual property owner, or breach any laws, rules, or government regulations, or infringe any contracts, or rights of third parties. You agree to indemnify Nu Skin, its affiliates, officers, directors, employees and agents, and their successors, and assigns (including any agency, client, broadcaster, periodical, or other publication), fully from any liability resulting from your breach of this section.
13. You understand and agree that:
  - a. Nu Skin may use all the Content submitted by you for the Contest in any form and in any media, including without limitation, in printed publications, promotional material (including online), and in all manner, in their original format or edited or altered in any way, without limitation as to frequency or duration, for marketing and/or promotional purposes.

  - e.
